### Florida DBPR Definition of Mold Assessment

#### The 2021 Florida Statutes. 468.8411

(3) "Mold assessment" means a process performed by a mold assessor that includes the **physical sampling** and detailed evaluation of data obtained from a building history and inspection to formulate an initial hypothesis about the **origin**, **identity**, **location**, and **extent** of amplification of mold growth of **greater than 10 square feet**.

- If the Carrier inspection did not determine the origin, identity, location and extent of mold > 10 sq ft, its not a DBPR defined mold assessment.
- The law does not limit assessments to visible/ non-intrusive inspections.

### Florida DBPR Definition of Mold Remediation

The 2021 Florida Statutes. 468.8411

(5) "Mold remediation" means the removal, cleaning, sanitizing, demolition, or other treatment, including preventive activities (such as drying), of mold or moldcontaminated matter of greater than 10 square feet ...

When performing water damage restoration, the key words here ... when > 10 sq ft of mold:

 Preventive activities: Includes both the application of biocides as well as drying are illegal mold remediation

Mold starts to grow in 24–48 hours per EPA/FEMA/OSHA/CDC.

Water damage from wind driven rain from a hurricane can NEVER be properly and fully restored by drying. Response can NEVER be fast enough. And/or no power. Dry-out contractors ALWAYS cover up/hide failed drying after a storm with ALWAYS illegally applied biocides. Leaves a toxic residue. Hurts homes. Hurts babies

### S500 and Illegal Antimicrobial (Biocide) Use

Antimicrobial (biocide) Risk Management Restorers should obtain a written informed consent from the customer before they are applied, and occupants should be evacuated prior to application.

**Restorers shall follow label directions and** comply with federal, state, provincial, and local regulations. (S500-202112.3.10.1) • **CALCULATE ON CONTRACT OF A Series of Section 2017 CONTRACT OF A Section 2017 Disinfectant-Cleaner-Sanitizer-Fungicide Disinfectant-Cleaner-Sa** 

- Obtain written informed consent before applying biocides.
- This is not a line in the work order that says that Contractor may use biocides/ antifungals and by signing, contractors hereby agree.
- "Shall" (means required by law) follow label directions.

Even though widely sprayed on drywall to cover up mold and bacterial growth/odors, there are NO EPA Registered Biocides that can legally be used on any porous or semi-porous materials (such as drywall). Use on drywall is contrary to Federal Law (FIFRA). Illegal application of biocides = Invoice not enforceable.

### Plant Based Biocides Such as BotaniClean. Not Exempt

When used as directed, BotaniClean effectively cleans and disinfects hard, non-porous environmental surfaces such as: ambulance patient care surfaces, anesthesia equipment surfaces, baby/infant care surfaces, backboards, bathing units, bathrooms, bed railings, blood pressure devices, cabinets, chairs, changing tables, computer surfaces, countertops, CT equipment/surfaces, curing lights, dental equipment surfaces/devices, doorknobs, floors, garbage <section-header>

- Plant based biocides are not exempt. They are EPA regulated/ EPA RESTRICTED USE.
- Hard surfaces only. Not on drywall.
- If there is a line item in the Contractor invoice for antimicrobial application (plant based or otherwise)...
- Illegal contracting. Invoice is not enforceable.
- It may be that everyone is doing it, that does not mean it is okay. Does not mean it is legal.

### UNDER NEW FLORIDA SUPREME COURT RULING

- Under new Florida Supreme Court ruling (1-1-25) 1.510 (c) ...
- Find > 10 sq ft of mold after dry-out. Have judge issue Summary Judgement against Carrier FOR PAYING FOR ILLEGAL DRYING that did not restore.
- Sue dry-out contractor for Fraud. Used illegal biocides to cover up failed drying.
- Sue for personal injury. Drying when mold spreads contaminants. Damages homes.
- Results in sick kids.
- Spraying with biocides to cover up failed drying. Leaves a toxic biocide residue. Hurts kids.
- Horrible. Paid for by Florida approved Carriers.

### **HOW CAN THIS BE HAPPENING?**

- In Florida: Water damage training classes sponsored by IICRC do not in any way teach Florida Mold Assessment /Mold Remediation Laws where if mold > 10 sq ft, drying is illegal mold remediation.
- In Florida: Xactimate has no procedures for compliance with Florida Mold Laws.
- SB 2-A allows Florida Carriers to cheat homeowners and leave sick homes / sick babies without recourse.
- With SB 2-A, only the rich that can hire their own lawyers have coverage. Everyone else pays for insurance but from a practical manner, have none.
- What a horrible disgrace for our great state.
